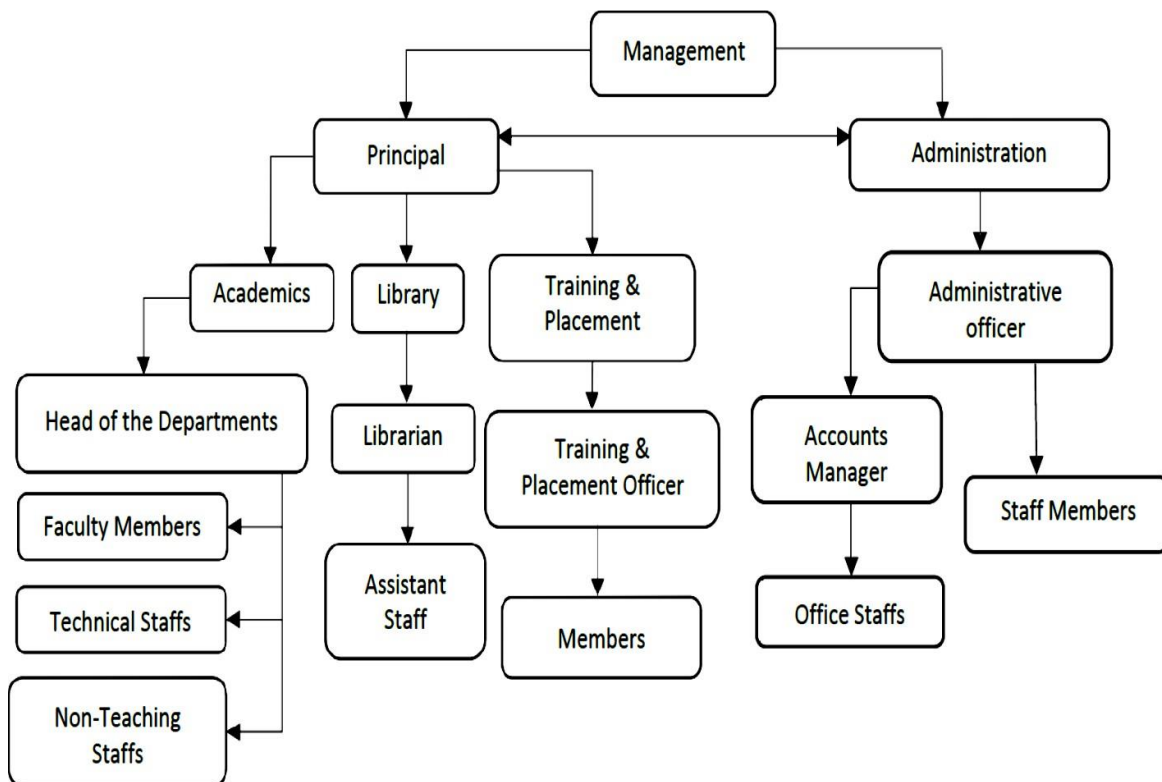

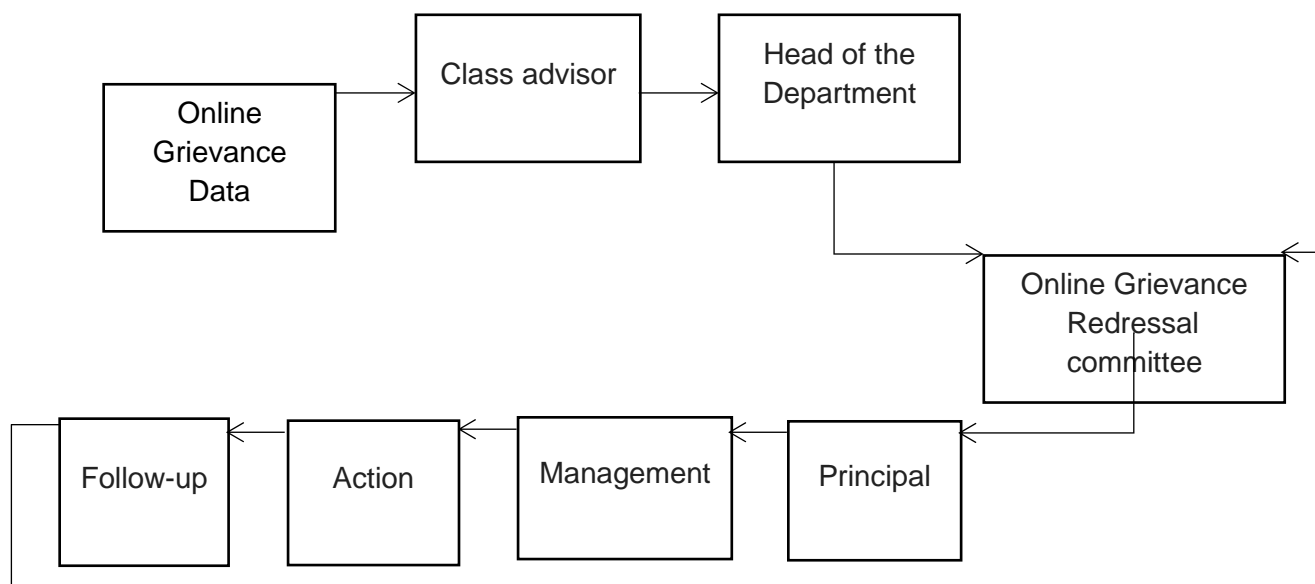
- **Organizational chart**
